THE WANDERING X

I have noticed the wandering placement of the serial number on the CTC 3-C prefix X. From the few notes I have, the serial number is placed as far left as the first O in Corporation to as far right as the second R in Corporation. I have only had 8 or 9 of these bills so I don't know if it travels any further left or right.

The serial number seems to be within 1mm for height placement. All serial numbers 3, 4, 5 or 6 digits seems to measure 25 mm in length.

If anyone has a CTC 3-C prefix X or the CTC 2-C prefix C with a serial number outside of the placements I have shown. I would be interested in purchasing them to add to my collection. As I have no computer or fax, I can be reached by mail or phone 613-342-0484 through the day.
